

ICC Membership Terms and Agreements

By purchasing any annual or subscription-based membership to access ICC content for any specified period of time (collectively and individually referred to herein as the “Membership”), you acknowledge and agree to the following:

1. Do not share your Membership username or password with others. This will result in the immediate termination of Membership.
2. You agree not to reproduce, duplicate, copy, sell, resell, or exploit for any commercial purposes any portion of the content available through the Membership.
3. ICC reserves the right to refuse Membership or to cancel Membership at any time for any reason.
4. Upon termination of Membership, all benefits of Membership are waived and forfeited irrespective the amount of membership paid.
5. Upon written request for cancellation of membership:
 - Up to 72 hours, 100% of New Family Fee and Membership fees are refundable.
 - Up to 30 days, 90% of all fees are refundable.
 - After 30 days, fees are non-refundable, regardless of the frequency with which you accessed the Membership content.
6. YOU WILL BE BILLED FOR THE MEMBERSHIP IN ACCORDANCE WITH THE QUOTED MEMBERSHIP FEE. IF THE MEMBERSHIP THAT YOU PURCHASED IS A MONTHLY MEMBERSHIP, YOU WILL BE AUTOMATICALLY BILLED EACH MONTH, UNTIL AND UNLESS YOU CONTACT ICC TO CANCEL YOUR MEMBERSHIP. YOU MUST CANCEL BEFORE THE NEXT BILLING DATE IN ORDER TO AVOID A CHARGE FOR THE FOLLOWING MONTH-LONG PERIOD. YOU MAY CANCEL YOUR MEMBERSHIP BY EMAILING PAYMENT.ADMIN@ICCINC.ORG. UNTIL YOU TERMINATE YOUR MEMBERSHIP, YOU AUTHORIZE OUR BILLING COMPANY TO CHARGE YOUR CREDIT CARD (OR OTHER APPROVED FACILITY OR MECHANISM) FOR THE DURATION OF YOUR MEMBERSHIP SUBSCRIPTION.
7. It is your responsibility to inform ICC of any of the following changes in your credit card or debit account:
 - Change in home or billing address or other contact information;
 - change in security code;
 - apparent breach of security of your username or password, such that unauthorized access to the Membership is possible;

Unless you give proper notice of any such event, you agree to pay all charges for unauthorized use of the Membership through your account. In addition, ICC shall not be responsible for any bank overdraft fees, charges for exceeding credit limits, or any other fees or charges that may be imposed by your bank or credit card company. If your credit or debit card is declined for any reason, you will be sent an invoice for the amount due, and you agree to pay that invoice.
